HIGH LEVEL MEETING FOR THE FINALIZATION AND ADOPTION OF THE LBA PROTOCOL FOR THE ABIDJAN CONVENTION AND STRATEGIC ACTION PROGRAMME (SAP) 25-29 June, 2007

The week of 25-29 June, 2007 marked an important stage in the life of the GCLME, as it was dedicated to the finalization and adoption of the Land and Sea Based Activities (LBA) Protocol for the Abidjan Convention and the regional Strategic Action Programme (SAP), two key documents and indicators of progress for the Project.

The Meeting, opened by the Minister for Local Government, Rural Development and Environment, Ghana, Hon. Stephen Asamoah Boateng, attracted over 50 participants including GCLME countries' National Directors, UN agencies representatives, NGO's and consultants for the GCLME. Also in attendance were representatives from three non-GCLME countries but parties to the Abidjan Convention.

Prof. Chidi Ibe, Executive Secretary, IGCC and Regional Director, GCLME welcomed the delegates to the IGCC Secretariat and the workshop.

Representatives from UNIDO, UNDP and UNEP made brief statements each commending the Executive Secretariat and his staff for the achievements made so far. They also reconfirmed continued support from their organizations.

In his Keynote Address, Hon. Asamoah Boateng restated Ghana's continued support to the project and lauded the 16 GCLME member countries for their commitment to the Project as it demonstrated their ownership of it and collective will towards solving the trans-boundary problems confronting their coastal and marine environment.

Prof. Alo Babajide, the chair of the meeting urged the few countries that have not finalized their National Action Plan (NAP) documents to do so as a matter of urgency.

The LBA Protocol will be presented at the joint Conference of Parties of the Nairobi and Abidjan Conventions in South Africa September 10 - 14 for adoption while the SAP Document is due for signing at the Ministerial Meeting envisaged for October-November, 2007.

Co-operation Between IGCC and FAO

As part of efforts to enhance the recovery of fish stocks and ensure fish food security for the GCLME region's over 300 million people, the Interim Guinea Current Commission seeks to enlist the support of regional and sub- regional fisheries bodies within the region to fulfill its mandate of:

- Promoting the sustainable utilization of living marine resources and
- Addressing common problems of fisheries management and development confronting member states.

It is against this background that the Deputy Minister for Fisheries of Ghana, Hon. Daniel Dugan, on behalf of the IGCC, embarked on a 6 day mission to the FAO in Rome, Italy from 25 to 30 May, 2007, to solicit FAO's advice and assistance and to discuss expanded programmatic cooperation between the FAO and the IGCC.

The Hon. Minister held discussions with a team of FAO officials consisting of the Director of the Fisheries and Aquaculture Management Division, Mr. Jorge Csirke, Fisheries Research Officer, Ms. Merete Tanstad and the Chief of International Institutions and Liaison Service, Mr. Ndiaga Gueye.

FAO's support and expertise was requested in the following areas:

- Integrated Coastal Management towards the attainment of IGCC's objective of restoring degraded habitats through education on good environmental practices and training of fisher folk in alternative livelihoods.
- Technical assistance to the Monitoring Control and Surveillance (MCS) Division of the Ministry of Fisheries of Ghana, to strengthen its Vessel Monitoring System (VMS), to accommodate member countries of the IGCC.

- Assistance in analyzing the time series survey data and propounding models for fisheries management by IGCC countries.
- Collaboration with the WWF and IGCC to encourage and assist member countries to develop political will and to harmonize the formulation of minimum terms and conditions for negotiating Access/Partnership Agreements to their advantage.

Mr. Csirke reiterated FAO's sustained commitment to the IGCC/FAO partnership for the implementation of Ecosystem based Fisheries Management in the GCLME region through the Nansen Research Surveys.

The FAO will commit technical and scientific support to the IGCC and assist member countries to source for funds to improve Fisheries Surveys and Research.

To enhance and expand Ghana's MCS/VMS to accommodate other countries in the region, the FAO will invite Ghana to participate in its International Plan of Action to monitor vessels operating in the region.

The FAO team advised developing nations to apply the Code of Conduct for Responsible Fisheries, as well as their national fisheries laws, as a guide, when entering into Access/Partnership Agreements.

The FAO commended the IGCC for its role in promoting the recovery and sustainability of depleted fisheries and living marine resources and pledged their continued support towards the management of fisheries resources in the GCLME region.

The IGCC salutes FAO and especially the team led by Dr. Jorge Csirke for the warm welcome accorded the Hon. Deputy Minister and for the enlightened discussions with him.

Catching the "little guys" - Successful tow of CPR in the GCLME

A continuous plankton recorder (CPR) was successfully deployed from the RV Fridtjof Nansen on June 2nd as part of the annual fish trawl survey in the GCLME. The CPR was successfully towed from Tema (Ghana) to Cote d'Ivoire Liberia border, and later on in the month, from Benin to Cameroon.

During the Pilot Phase of the project involving six countries, the necessary capacity for CPR survey was developed in the region. For this year, Mr Michael Oyebanji of NIOMR was the Plankton Expert on board during the first and second CPR tows. Plankton monitoring using CPR is the most cost effective method of collecting samples. The samples were sent to the GCLME Productivity and Biodiversity Centre in Ghana for analysis.

Plankton survey forms an integral part of the GCLME project and is one of the Regional demonstration projects. Plankton, the "little guys" of the oceans, form the basis of the food chain in the oceans and without them the ocean will be as barren as a desert. The very large whale feeds solely on plankton (called krills or euphausiids). The importance of the regional demonstration project on productivity is in line with assessment of plankton as primary food source for fish and other living marine resources.
