



## Report of the third ordinary Meeting of the Lake Tanganyika Conference of Ministers



*Uvira, Democratic Republic of Congo*

*August 21, 2009*



**Introduction:**

The third ordinary meeting of the Lake Tanganyika Conference of Ministers was held in Uvira, Democratic Republic of Congo on August 21, 2009. Delegates from the four Lake Tanganyika riparian countries were led by Honourable Déogratias NDUWIMANA, Minister of Water, Environment, Territory Management and Urban Planning of Burundi, Honourable Norbert Basengezi KATINTIMA, Minister of Agriculture, Fisheries and Livestock of the Democratic Republic of Congo, Honourable Dr. Batilda S. BURIAN, Minister of State, Vice-President's Office in charge of Environment of the United Republic of Tanzania and Honourable Moses MWANGALA, Deputy Minister of Tourism, Environment and Natural Resources of Zambia.

Staff members from the Lake Tanganyika Authority (LTA) Secretariat, United Nations Development Programme / Global Environment Facility (UNDP/GEF) Regional Coordination Office, National Coordination Units and Project Management Units attended the meeting. Representatives of the following partner organizations: UNDP/GEF, the African Development Bank (ADB), Food and Agriculture Organization of the United Nations (FAO), the World Conservation Union (IUCN) and World Agroforestry Centre (ICRAF) also attended the meeting.

The Provisional Agenda, the Programme, the Conference Declaration as well as the complete list of delegates are respectively included in Appendices 1, 2, 3 and 4 of the report. Statements made by the Heads of delegation are included in Appendices 5, 6, 7 and 8.

**Agenda Item 1: The Opening Ceremony****Agenda Item 1.1 Welcome Remarks and Statements from Heads of Delegation**

The Opening Ceremony was graced by the presence of His Excellency Mr. Déogratias NDUWIMANA, Burundian Minister of Water, Environment, Territory Management and Urban Planning and outgoing Chairman of the Lake Tanganyika Conference of Ministers.

Before the official opening of the Conference, His Excellency Mr. Jean Claude Kibala NKOLDE, Deputy Governor of South Kivu Province delivered his welcome remarks and this was followed by statements from heads of delegation. The first statement was made by His Excellency Norbert Basengezi KATINTIMA, Minister of Agriculture, Fisheries and Livestock of the Democratic Republic of Congo. In his statement, His Excellency KATINTIMA welcomed all delegates and stated that it was a historical moment to hold such a high profile meeting in a small town of Uvira. His Excellency KATINTIMA went on to thank the African Development Bank for the first disbursements especially at National Coordination Unit (NCU) levels. He also recognized the efforts made by other supporting partners and encouraged them to continue because the Lake Tanganyika integrated management programme constitutes a relief for the Lake Tanganyika basin populations. His Excellency KATINTIMA concluded his statement by calling upon the Lake Tanganyika riparian countries to continue supporting the LTA.

The head of the Zambian delegation, Honourable MWANGALA thanked supporting partners and requested them to continue providing invaluable support to the Lake Tanganyika regional integrated

management programme; he also took this opportunity to announce Zambia's offer to organise and host the 4<sup>th</sup> Conference of Ministers meeting in liaison with the LTA Secretariat.

In her statement, the head of the Tanzanian delegation, Honourable Dr. BURIAN, Minister of State in the Vice-President Office in charge of Environment, thanked the Democratic Republic of Congo for the hospitality and applauded the choice of Uvira to host the third Lake Tanganyika Conference of Ministers. Honourable BURIAN said that when Tanzania hosts the Conference of Ministers meeting, the venue will be Kigoma, a city on the shores of Lake Tanganyika.

#### **Agenda Item 1.2 Statements from partners**

Dr. Akiko YAMAMOTO representing UNDP/GEF thanked the Democratic Republic of Congo for choosing Uvira as the venue for the third Lake Tanganyika Conference of Ministers. She provided some details on the UNDP/GEF project interventions and expressed happiness that the LTA Secretariat is now in place with the mandate to guide the implementation of project activities. She also emphasized that the UNDP/GEF project objective is to contribute to socio-economic development of the Lake Tanganyika riparian populations and promote sustainable management of the Lake Tanganyika biodiversity.

Mr. Jean-Louis KROMER, the ADB representative, informed the meeting that ADB hoped that the activities in all the National Coordination Units will have started by the end of year 2009. He also announced that conditions for the regional level and three national levels for Burundi, Democratic Republic of Congo and in Tanzania had been fulfilled for the first disbursements of the grant and loans. The ADB representative requested Zambia to fulfil all the conditions required for first disbursement of funds.

The FAO representative, Mr. Gerd MARMULLA, mentioned that although it was evident that fisheries ensure food security to riparian countries, there was need for the four riparian countries to collaborate and find solutions to the problem of overexploitation of natural resources of Lake Tanganyika and its basin. Mr. MARMULLA expressed happiness to see the presence of the four Ministers of the four riparian countries at the meeting because it confirmed their determination and commitment to the sustainable management of Lake Tanganyika natural resources for the benefit of the local people. He further informed the meeting that FAO had for many years supported activities especially in fisheries management on Lake Tanganyika and would work with LTA on the ADB supported project for the success of the Lake Tanganyika Integrated Region Development Programme.

The IUCN representative, Dr. Geoffrey HOWARD, thanked the Government of the Democratic Republic of Congo for hosting the meeting. He told the meeting that IUCN had for many years supported valuation activities on Lake Tanganyika and would continue to collaborate with Lake Tanganyika Authority as one of its development partners.

### **Agenda Item 1.3 Head of Delegation Statement and Opening Remarks**

His Excellency, Déogratias NDUWIMANA, Burundian Minister of Water, Environment, Territory Management and Urban Planning officially opened the meeting in his capacity as Chairman of the Lake Tanganyika Conference of Ministers. His Excellency NDUWIMANA thanked the Congolese Government and people for their hospitality and then expressed his happiness at the efforts so far made aimed at sustainable management of Lake Tanganyika and its basin and reminded delegates that there was still a lot more that needed to be done.

His Excellency NDUWIMANA expressed gratitude for the opportunity to have served as Chairman of the Conference of Ministers and promised to give his support to the in-coming Chairman, His Excellency KATINTIMA, the Congolese Minister of Agriculture, Fisheries and Livestock. Regarding the national obligations for each Lake Tanganyika riparian country, the out-going Chairman reminded his colleagues to make sure that national contributions to LTA from their respective governments are transferred at the beginning of the year in order to avoid disruption of the operations of the LTA and the NCUs. The out-going Chairman concluded his remarks by transferring the chairmanship to His Excellency KATINTIMA and thereafter declared the third ordinary meeting of the Lake Tanganyika Conference of Ministers formally opened.

### **Agenda Item 2: Consultations among Heads of Delegation**

After the Opening Ceremony, Heads of delegation took a moment for consultations behind closed doors.

### **Agenda Item 3: Constitution of the Bureau**

When the meeting resumed following consultations between Heads of delegation, His Excellency Mr. Norbert Basengezi KATINTIMA, the Congolese Minister of Agriculture, Fisheries and Livestock formally took up the Chairmanship and immediately called the meeting to order. In line with an earlier statement made by the Head of the Zambian delegation, the Chairman announced that Zambia was going to host the fourth ordinary meeting of the Conference of Ministers at a venue to be communicated in due course. Furthermore, the Chairman announced the bureau as follows:

The Conference Chair: the Democratic Republic of Congo  
The Vice- Chair: Zambia (being the next host of the Conference of Ministers meeting)  
Rapporteurs: Burundi for French speakers and Tanzania for English speakers.

### **Agenda Item 4: Adoption of the Agenda and Programme**

The Chairman invited delegates to go through the Agenda and thereafter invited proposals for adoption. Burundi proposed that the agenda be adopted and this was seconded by Tanzania.

## **Agenda Item 5: Matters arising from the 2<sup>nd</sup> Conference of Ministers meeting**

### **5.1     *Fulfillment of national and regional level ADB conditions***

The ADB representative announced that conditions for first disbursements at the regional level: LTA and three national levels: Burundi, Democratic Republic of Congo and Tanzania had been fulfilled and the first disbursements had been transferred. The Conference of Ministers called upon Zambia to expedite fulfilment of the ADB conditions.

### **5.2     *National contributions***

The Secretariat reported that national contributions had been received from Burundi and Tanzania while a portion of the national contributions had been received from Zambia. The DR Congo delegation reported that the national contributions were in the pipeline. The Conference of Ministers called upon all the Contracting Parties to expedite remittance of full national contributions to the LTA.

### **5.3     *Appointment of LTA and NCU staff members***

The second meeting expressed concern over lengthy delays in achieving full operations of both the LTA and NCUs and proposed some action points to resolve the matter – the meeting recommended that all key LTA and NCU positions be filled not later than June / July, 2008. At the regional level, only the position of Director of Fisheries was remaining to be filled, the Tanzanian delegation informed the meeting that a suitable candidate would be nominated before the end of September, 2009. At national levels, the National Coordinator for Zambia had not yet been hired. The Zambian delegation reported that the hiring process had already started.

## **Agenda Item 6: Consideration of the Report of the third Management Committee meeting.**

The Management Committee Chairman Mr. Eric MUGURUSI presented the report of the third Management Committee meeting which was held from 19<sup>th</sup> to 20<sup>th</sup> August 2009. In his presentation, he mentioned that the Management Committee meeting was preceded by an inception workshop for the UNDP/GEF project for which the workplan was adopted. The Management Committee Chairman then presented a detailed Management Committee report and invited the third Conference of Ministers meeting to take note of the decisions made by the Management Committee. Furthermore, the Management Committee Chairman invited the third Conference of Ministers meeting to consider and approve a number of recommendations.

### **6.1     *Management Committee decisions for Conference of Ministers attention***

The Management Committee Chairman invited the third Conference of Ministers to take note of the following decisions made by the Management Committee.

- **Terms of Reference for the Regional Steering Committee:** The Management Committee requested the LTA Secretariat to prepare and circulate Terms of Reference for the Regional Steering Committee by October 19, 2009;
- **Fact-finding mission:** The Management Committee requested the LTA Secretariat to prepare terms of reference and commission a fact-finding mission on the problems of declining water levels, deforestation and sedimentation. It was decided that this would be done as one of the activities under the UNDP-GEF Project;
- **LTA programme and project activities:** The Management Committee took note of the LTA programme activities, but in the absence of a full complement of staff, the Management Committee requested the LTA Secretariat to prepare a detailed and comprehensive report of activities including the budget for consideration at the next meeting. The workplan for the UNDP-GEF Project was considered and endorsed;
- **National level programme and project activities:** The Management Committee took note of the progress and achievements made by the National Coordination Units for Burundi, DR Congo and Tanzania. Furthermore, the Management Committee took note of the progress and achievements made by the UNDP-GEF Projects in Zambia and Tanzania;
- **Resource mobilization:** The Management Committee requested the LTA Secretariat to prepare terms of reference for the LTA/Management Committee resource mobilization programme for consideration at the next Management Committee meeting ;
- **Amendment of the present Convention:** The Management Committee noted that the Conference of Ministers at the second meeting endorsed the composition of Management Committee per Contracting Party to be increased from three to four representing experts from fisheries, water, environment and finance. Therefore, the Management Committee proposed amendment of Article 25 of the present Convention which states that each Contracting Party will appoint three members of the Management Committee. The Management Committee also noted the request by ADB to be included on the list of observers as provided for under Article 24 of the present Convention. The LTA Secretariat was asked to liaise with Contracting Parties in drafting the amendment for consideration at the next meeting;
- **LTA/FAO Agreement:** The Management Committee noted the progress made in drafting the LTA/FAO Agreement for technical assistance under the ADB grant to the LTA. The LTA Secretariat was requested to expedite finalization of the Agreement.

The Conference of Ministers appreciated the efforts made by the Management Committee and took note of the decisions of the Management Committee.

## **5.2     *Management Committee recommendations for consideration and approval***

The Management Committee Chairman reported that the Committee considered and amended the working documents presented by the LTA Secretariat and thereafter invited the Conference of Ministers to consider and approve the revised documents.

- **Draft Lake Tanganyika Authority Headquarters Agreement:** Resolution 3 of the first Conference of Ministers directed the “Executive Director to negotiate and finalize the draft Headquarters Agreement with the Government of the Host country.” – the Host Government head of

delegation informed the Conference of Ministers that the Agreement had been negotiated and was going to be signed two weeks after the third Conference of Ministers;

- **Draft Rules of Procedure of the Lake Tanganyika Authority:** Resolution 7 of the first Conference of Ministers directed the “Executive Director, in consultation with the State Parties to the Convention and the DRC to finalize the draft Rules of Procedures for submission and approval by the Conference of Ministers.” The LTA Secretariat presented the finalized document to the Management Committee for review;
- **Draft Financial Regulations of the Lake Tanganyika Authority:** Resolution 8 of the first Conference of Ministers directed the “Executive Director, in consultation with the State Parties to the Convention and the DRC to finalize the draft Financial Regulations for submission and approval by the Conference of Ministers.” The LTA Secretariat presented the finalized document to the Management Committee for review;
- **Draft Rules and Conditions of Service of the Lake Tanganyika Authority:** The Interim Secretariat undertook a regional survey of Staff Rules and Conditions of Service of organizations similar to LTA and submitted the draft to the LTA Secretariat for completion. The LTA Secretariat presented the finalized document to the Management Committee for review;
- **LTA Logo / emblem:** The LTA Secretariat invited the public in the four Lake Tanganyika riparian countries to participate in designing the logo for the LTA. Twenty-nine designs were submitted and the LTA Secretariat presented all the submissions to the Management Committee to short-list the best four and present to the Conference of Ministers to select the best. Submissions by Bennett, Theosdedit, Edwin and Godfrey were short-listed;
- **Nominee for the position of LTA Director of Monitoring and Evaluation:** The Zambian delegation to the Management Committee meeting presented a report on the process followed to nominate the candidate for the position of Director of Monitoring and Evaluation for the LTA. During the Conference of Ministers, the head of the Zambian delegation, presented Mr. Augustine MUTELEKESHA as the nominee for the position of Director of Monitoring and Evaluation for the LTA for approval.

The Conference of Ministers appreciated the efforts made by the Management Committee and approved the revised working documents. Furthermore, the Conference of Ministers selected the logo by Bennett as the best and approved the nomination of Mr. Augustine MUTELEKESHA for formal appointment as Director of Monitoring and Evaluation for the LTA. Finally, the Conference of Ministers called upon the LTA Headquarters host government to expeditiously sign the LTA Headquarters Agreement with the LTA.

#### **Agenda Item 7: Date and venue for the fourth Conference of Ministers meeting**

The Zambian head of delegation reaffirmed Zambia’s offer to host the fourth Conference of Ministers meeting. The head of delegation said that the venue will be determined in due course. The Conference of Ministers welcomed Zambia’s offer.

#### **Agenda Item 8: Any Other Business**

No any other business item was raised by any of the four delegations.

**Agenda Item 9: Declaration of the third Conference of Ministers meeting**

Dr. Henry MWIMA, LTA Executive Director read the Declaration of the third Conference of Ministers meeting. The signed Declaration is in Appendix 3.

**Agenda Item 10: Adoption of the third Conference of Ministers meeting**

Minutes of the third Conference of Ministers meeting will be adopted at the next meeting.

**Agenda Item 11: Closure of the meeting**

His Excellency Norbert Basengezi KATINTIMA, Minister of Agriculture, Fisheries and Livestock of the Democratic Republic of Congo, in his capacity as Chairman of the Conference of Ministers, officially closed the meeting at 17.15 hours. In his closing remarks, His Excellency KATINTIMA thanked the member countries and cooperating partners for their commitment and continued support for the sustainable management of Lake Tanganyika and its basin for the benefit of the riparian communities. He also thanked members and observers for their active participation during the meeting deliberations.



We also noted the challenges caused by the climate change and its implications on the Lake and its environment; we believed the updated Strategic Action Programme will address this as a cross-cutting issue.


