

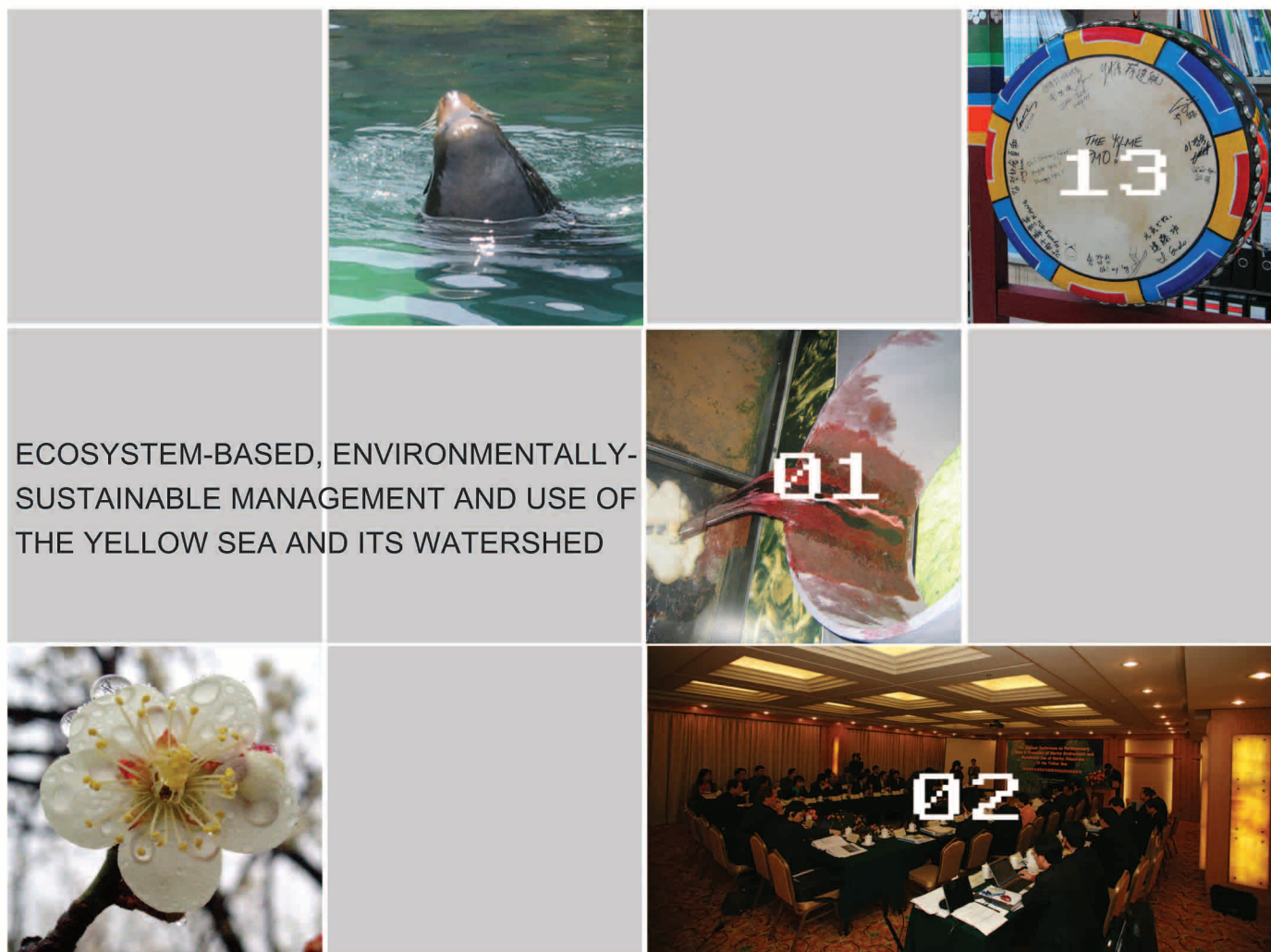

## KOREA NGO Workshop

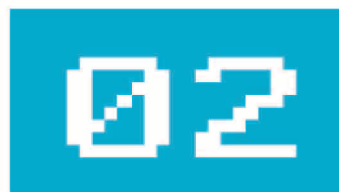
As one of public awareness activities under the Yellow Sea Partnership (<http://www.yslme.org/partnership/>), the “Korea NGO Workshop” was held in Ansan, Korea, 15-16 June 2006 to promote co-operation with local NGOs. More than 30 participants from over 12 NGOs, 1 government-affiliated institution, and 3 international organisations and projects attended the workshop. It was the second time for the YSLME Project to host this kind of workshop, targeting NGOs; the first Yellow Sea Partnership Workshop was organised in Beijing, China, in March 2006.

The representatives of the Korean local NGOs as well as the international organisations made presentations on their activities with respect to environmental conservation in the Yellow Sea. The PMO also presented the Yellow Sea Partnership and introduced the results of its first workshop in China. The meeting then discussed how to strengthen the co-operation between Korean NGOs and the Yellow Sea Partnership.

## Parliamentary Conference: A GEF “FIRST”

The “Regional Conference on Parliamentary Roles in Protection of Marine Environment and Sustainable Use of Marine Resources in the Yellow Sea” was organized in Qingdao, China, 28-30 March 2006, as one of the public awareness activities of the Yellow Sea Project.

This Conference, the first meeting of its kind under GEF projects, provided a forum where parliamentary members gathered to discuss marine environmental issues, and aimed to enhance the participation of a major stakeholder—the parliament—in the activities to protect the marine ecosystem and promote the sustainable use of marine and coastal resources.

Forty one participants from both China and Republic of Korea attended the meeting, including fourteen members from the parliamentary organizations. The parliamentary members as well as the regional experts made presentations on the environmental status, the needs and requirements for environmental protection, the legislative consideration of marine environmental protection, and the economic consideration of conserving marine resources. Panel discussions were conducted to address the active involvement of stakeholders such as NGOs, industries, and local communities in conservation activities. As a result of the Conference, the participating parliamentary members deepened their understanding of the serious environmental degradation in the Yellow Sea and recognised the strong need for taking action to address the problem.

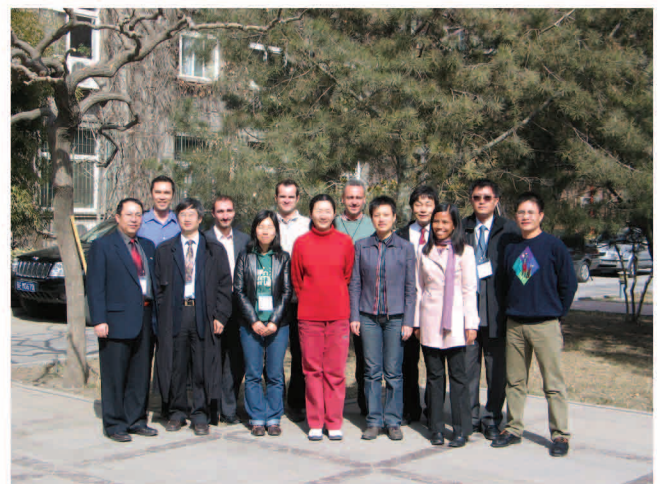

## Yellow Sea Partnership Workshop

A "Yellow Sea Partnership Workshop" was held (Beijing, China, 15-16 March 2006) with the objective to agree upon the final format of the YSP Public Awareness and Communications Strategy, and develop a mechanism for the co-operative participation of the members of the 'Yellow Sea Partnership' in an effort to raise local, national, regional and international awareness of the problems faced by the Yellow Sea and how the ecosystem can be improved by the mitigation or elimination of these problems. It is anticipated that this effort will lead to the strengthening of public support and participation in actions leading to the mitigation or elimination of these problems.

This public awareness and communications strategy was developed to produce a basic framework for coordinated actions of the numerous groups involved in the 'Yellow Sea Partnership (YSP)', including initially the YSLME, the WWF/KEI/KORDI Yellow Sea Eco-region Planning Programme (YSEPP), the MSC, and Wetlands International. The partnership is open and available for participation by any organisation interested in the activities identified in this strategy and additional partnerships have since been pursued.

The successful outcomes from the workshop were:

1. An Agreement on the Yellow Sea Partnership Strategy - Its aims, purpose, targets/stakeholders, key messages, calls-to-actions and expected outcomes.
2. An agreed mechanism of operation for the Partnership.
3. Agreement on areas of collaboration, contribution and responsibility, and timing of activities.
4. An Agreement on Methods for the Evaluation of Success.
5. A Statement of Cooperation ratified by participating entities for the YS Partnership.



## Synthesis of national data and information

Consultants for the activity of regional data and information synthesis have been hired. One consultant for each of the environmental components has been hired, and all four consultants have started to analyse the data and information provided by the countries. The regional synthesis results-to-date will be presented at the third round of RWG meetings during August and September.



## Inter-Calibration Exercise - Round 1

The first round of nutrient inter-calibration exercise was completed in May. All together, seven labs (4 from China and 3 from Korea) participated in the exercise to compare their analytical results for nutrients in sea water. The tested nutrients were nitrate, nitrite, ammonia, phosphates, and silicates. The final report and results are available upon request from the PMO ([info@yslme.org](mailto:info@yslme.org)). The seven labs will participate in Round 2 using a different set of standards to test for the same compounds. Some labs may also alter their analytical methods based on the recommendations for improvement from Round 1.



## One Step Closer to the TDA

Work has begun on the regional syntheses of pollution and ecosystem data and information collected at the national level that will be used for the Transboundary Diagnostic Analysis (TDA). The consultants and institutions carrying out this activity are working with the national data collection teams to gather and assess the data, and will provide their final products during the middle of the year when work on the TDA is expected to begin.

## Biodiversity Component Moves Towards TDA

A contract has been awarded to National Fisheries Research and Development Institute, Pusan, Korea, to collate and summarize Korean national biodiversity data and information for use in the development of the TDA.

A contract has been awarded to the NGO, Wetlands International, based in Beijing, China, to prepare a regional synthesis of data and information for biodiversity of the Yellow Sea and prepare a regional strategy for the development and management of habitat and species diversity through development of protected areas for the conservation and restoration of vulnerable species.



## Fisheries Component Begins New Activities

A contract to develop a regional strategy for stock assessment of Yellow Sea fisheries has been awarded to a scientist from the Yellow Seas Fisheries Research Institute (China). The consultant will work with the RWG-Fisheries over the next few years to finalize the results which will be presented to the countries for evaluation.

A contract to establish the feasibility of a regional agreement for the use of fisheries resources in the Yellow Sea, and a proposal for measures to strengthen existing agreements, laws & regulations for the sustainable management of fisheries and mariculture in the Yellow Sea, has been awarded to the Marine Resource Assessment Group (MRAG), based in the UK with offices in the region. MRAG will work with the RWG-Fisheries over the next few years to finalize the results which will be presented to the countries for evaluation.

A contract has been issued to the Pusan National University, Pusan, Korea, for the development of regionally agreed methods for observing, monitoring and managing mariculture activities in the Yellow Sea, including guidelines for joint research programmes and training courses on sustainable mariculture.



## Pollution Component Completes a New Activity

Five laboratories in China and Korea participated in the nutrient intercalibration exercise. This activity was aimed to enhance analytical capacity and compare results from different labs and countries for better future comparison of data. The labs were provided with Standard Reference Materials of various nutrients in sea water, and had to analyse the references.

The results have been submitted to the Queensland Health Scientific Services, Australia, for processing. Each lab will be informed of its analysis results with recommendations on how to improve the analytical skills. The labs will apply the recommendations in the second round of this exercise, scheduled to take place during the middle of the year.



## Investment Component Contributes to Understanding Socio-Economy of the Yellow Sea

The new activities under the Investment Component include the Governance Analysis and the Environmental Valuation.

The Governance Analysis examines the political environment that affects the environmental problems in the Yellow Sea. The regional experts will analyse the stakeholders, institutions, laws, and policies that are relevant to the management of the Yellow Sea's ecosystem.

The Environmental Valuation assesses the economic aspects of the marine and coastal resources. The regional procedure for Valuation studies will be developed, focusing on specific ecosystem characteristics.

The results of both the Governance Analysis and the Environmental Valuation will be available this summer, and further details will be announced in future newsletters.



## PMO welcomes Mariculture Advisor

The PMO welcomes Mr. G. Ivan Soto who will join us during June and July. Ivan will assist the PMO in the implementation of mariculture activities related to the Fisheries Component. Ivan has aquaculture as his main field of expertise. Sustainable aquaculture and mariculture management issues were part of his duties while sharing his working experience with several international organizations in Asia, such as UNEP EAS/RCU, SEA START RC and FAO. Ivan will help the YSLME project to develop regional sustainable mariculture strategies, research on suitable carrying capacity guidelines for the region, and assess the fisheries and mariculture data collected at national level.

Trained in Aquacultural Engineering, Ivan has experience in aquaculture systems and sustainable aquaculture development in Latin America. His field of expertise allowed him to join international organizations such as FAO and UNEP prior to join the YSLME PMO. From 2001-2003, he worked for UNEP EAS/RCU with headquarters in Bangkok, Thailand assisting in the implementation of coral reef management projects and land based pollution programmes. Ivan holds a masters' degree on Aquatic Animal Resources Management from the Asian Institute of Technology, Bangkok, Thailand.

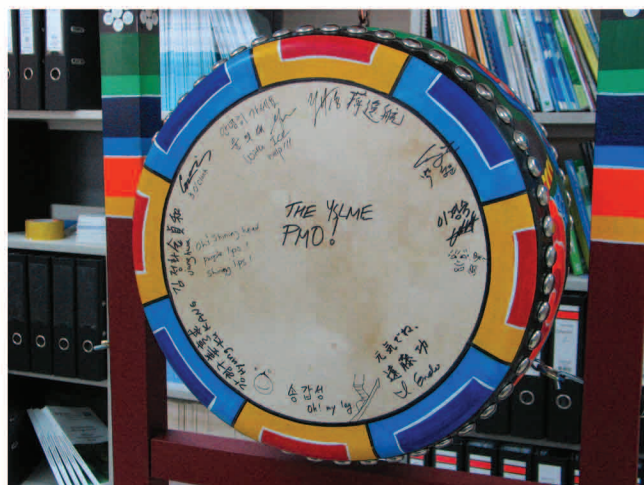
