The IGCC was informed of the sudden death of our former colleague and friend, Dr. Théodore Djama at the Kribi District Hospital, Cameroon, on 18 March, 2008.

Dr. Djama served as Fisheries Scientist at the Executive Secretariat of the IGCC for two years.

Born on 30 August, 1953, in Sangmelima, Cameroon, Dr. Djama held a Masters Degree and a PhD. in Fisheries from the University of Wales, United Kingdom. Before joining the GCLME Programme in 2005, he was head of the IRAD Station in Limbe, Cameroon. He has authored several scientific publications on fisheries, and represented Cameroon in ICAT (FAO) for many years.

He is survived by his wife, 4 children and 3 grand children.

## Sensitization and Information on the Abidjan Convention and IGCC.

Between 18 and 19 March, 2008, Benin organized a National Workshop on Sensitization and Information on the Abidjan Convention and the Guinea Current Large Marin Ecosystem Project (GCLME). The Workshop was attended by representatives from Ministries, Associations of Fishermen, Women Fish Wholesale Dealers and various structures intervening in the coastal area of Benin.

The Minister of Environment and Protection of Nature (MEPN), Benin, Madam Juliette Biao Koudonoukpo chaired the Opening Ceremony of the Workshop.

On welcoming participants, the National Director of Environment, Mrs. Dossou stressed the importance of the Workshop in Benin. She affirmed the great importance of the Project to the coastal areas.

Professor Sikirou ADAM, representing the IGCC Secretariat stressed the effects of pollution and environmental degradations. He also indicated these concerns are common to the GCLME countries.

The Minister of Environment and Protection of Nature (MEPN) gave a summary of pollution sources and other environmental degradation causes in Benin. She also indicated the remedy actions undertaken by the government so far.

On this note, she exhorted participants to also explore alternative means which could help in preserving the coastal areas.

During the working sessions, Mr Wabi Marcos, the National Consultant for pollution recalled the major types of pollution in the coastal areas of Benin and their sources.

Mr. Marcos updated participants with the legal/regulatory framework that have been set so far to prevent/

mitigate pollution from human activities.

Professor Sikirou Adam recalled the origin of the project and pointed out the achievements of the project which include:

- reinforcement of the capacities through the trainings of national experts in each member state of the project; and,
- realization of the coastal profile of each of the 16 Member States;
- realization of a regional Transboundary Diagnosis Analysis
- realization of a regional Strategic Action Plan
- preparation of National Programmes of action
